As indicated the ACEIE/UP group met this afternoon and is in the process to finalise our input National Integrated ICT Policy Green Paper (Green Paper).

I reported to the meeting on the conference of 3 March 2014 and mentioned to the meeting that you are contracted by the DoC to assist in finalising the Green Paper. The meeting compiled detailed minutes of our discussion this afternoon and it will be sent to you just after the weekend. Attached please find an electronic copy of the input/comments of the ACEIE / UP to the Green Paper.

In conclusion we wish to make a few remarks for your special consideration:

- We hope that the topic of Information Ethics could at least be identified as a cross-cutting theme for all the Conference Commission reports as compiled on 3 March 2014. You will remember that I also mentioned this to the Minister during the afternoon plenary session as Information Ethics in an important topic also for UNESCO and the coming WSIS event in 2015 . As you will notice Information Ethics topics were listed under most of the discussions of the Commissions

- The meeting indicated that it would be best if Information Ethics could be a separate Section in the Green Paper. Would you be able to lobby that?

- In both the mentioned two options the ACEIE/UP team offer to assist you in drafting the documents

Please see the detail in the minutes and our willingness and availability to assist in all the processes of the Green Paper, White Paper and related activities.
